1. Introduction

2. Information We Collect

A. Information You Provide to Us

We collect personal information that you voluntarily provide when you:

- Register for retreats, programs, or events
- Make a donation
- Subscribe to our newsletter
- Complete a contact form
- Communicate with us by email or phone

This information may include:

- Full name
- Email address
- Phone number
- Mailing address
- Payment information (processed securely by third-party providers)
- Emergency contact information (for retreat participation)
- Any additional information you choose to provide

If you register for a retreat or program, we may collect information necessary for administrative, logistical, or safety purposes.



B. Information Collected Automatically

When you visit the Site, we may automatically collect certain information about your device and usage through cookies and similar technologies, including:

- IP address
- Browser type
- Device type
- Pages visited
- Date and time of access
- Referring website
- Interaction data

This information helps us maintain the security, functionality, and performance of the Site.

3. How We Use Information

We may use personal information to:

- Process retreat and event registrations
- Process donations and provide receipts
- Communicate important information regarding programs or events
- Respond to inquiries
- Send newsletters or updates (if you have opted in)
- Improve our website and services
- Ensure the safety and security of participants
- Maintain appropriate organizational records

We do not sell personal information to third parties.

4. Donations and Payment Processing

Payments and donations made through the Site are processed by secure third-party payment processors. We do not store complete credit card information on our servers.

These third parties process payment information in accordance with their own privacy and security policies.

5. Cookies and Tracking Technologies



What Are Cookies?

Cookies are small text files stored on your device when you visit a website. They help websites function efficiently and provide information about how visitors use the Site.

How We Use Cookies

We may use cookies to:

- Enable essential website functionality
- Remember user preferences
- Analyze traffic and usage patterns
- Improve performance and user experience

We may use third-party analytics tools to better understand how visitors interact with our Site.

Managing Cookies

Most web browsers allow you to manage or disable cookies through browser settings. If you choose to disable cookies, some features of the Site may not function properly.

6. Disclosure of Information

We do not sell or rent personal information.

We may share information with:

- Service providers who assist in operating the Site or processing payments
- Program or retreat coordinators as necessary for administration
- Legal authorities if required to comply with applicable law
- Parties necessary to protect the safety, rights, or property of Casa ISKALI and its participants

Service providers are permitted to use personal information only as necessary to provide services on our behalf.

7. Children's Privacy

Our Site is not directed to children under the age of 13. We do not knowingly collect personal information from children under 13 without appropriate parental or guardian consent.



If minors participate in retreats or programs, parental or guardian consent may be required.

If we become aware that we have collected personal information from a child under 13 without proper consent, we will take steps to delete such information.

8. Data Security

We implement reasonable administrative, technical, and physical safeguards designed to protect personal information. However, no method of transmission over the Internet or electronic storage is completely secure, and we cannot guarantee absolute security.

9. Third-Party Links

Our Site may contain links to external websites. We are not responsible for the privacy practices or content of third-party websites. We encourage users to review the privacy policies of those sites.
